The international jury of leading experts awards pioneering achievements for innovative products on the basis sustainable criteria. The awards are proof of the superior quality of the product and a reliable seal of quality for buyers and consumers.

Awards that make performance visible

Applying and participating in the Awards means a lively exchange and networking with renowned actors and companies and becoming part of an international network. Participants use the marketing tools of the Awards for their communication, the proof of their performance and competence, as well as for their presence on the market.

Focus on decisive values

Materials used and innovative natural fibres, aesthetic and functional design, processing quality and resources, environmentally friendly production as well as social-ethical aspects are essential criteria for the award.

Textile ecological criteria

Textile ecology is a young topic, but in view of the scarcity of resources, dynamic population development, chemical and energy use, it is gaining dramatically in importance and poses major challenges for the textile industry and customer behaviour. Solutions to the problems arising worldwide for people and the environment in the extraction, further processing, finishing, making-up and transport of textile raw materials and the textile structures that extend to the finished market product all the way up to disposal and recycling are evaluated in this context.

- The ETA Award is unique in this industry environment and enjoys the highest recognition due to its expertise.
- The winners receive the "ETA-Award" figure.
- The winners will receive two copies of a high-quality award certificate.
- The ETA Award is widely publicised in print, online and social media and achieves theatre communicated in social media.
- The award winners will be provided with appropriate labels for corporate communication.
- The winning entries of the award winners will be published permanently in the online gallery including the link to the award-winning company.
- The jury provides all award winners with a short statement with reasons. This will be published in the online gallery and at presentations.
- The award-winning projects and products will be exhibited at the Int. Festival of Textile Craft, Textile Art & Design from 21-23 march 2025 at Maretsch Castle in Bolzano.

Submission / Nomination

Apply for the 2025 European Textile & Craft Awards and convince the jury that your performance deserves to be recognised and awarded. Admitted are the manufacturing industry, designers, craftsmen, artists, architects, universities and research institutions, museums, collectors, archives, hotels and restaurants.

Registration for the award is exclusively via the registration portal of the European Textile Academy (www.eurotextileacademy.com).

When submitting, please indicate on the registration form:

- Company address, the manufacturer's website and contact persons.
- The company must have been registered with the Chamber of Commerce or the Economic Chamber.
- Description of the activity and the product (max. 500 characters, dt/it/eng)
- Discipline or category. If your product does not correspond to any of the subcategories, please select "Other" at this point.

- For the submission, the product presentation must be sent in hybrid form, if possible. This means that you provide us with an original product, sample, fabric quality, etc. and additional digital presentation options for judging. In some categories, it is possible to submit only digital presentation materials.
- After receipt of your registration you will receive the invoice for your participation.

The following file formats are permitted as digital material:

- Up to 10 images as JPG with a maximum of 10.1 MB each
- Up to 5 videos as MP4 or MPG with a maximum of 1.4 GB each, recommended length: 2 min.
- Up to 5 PDF files with a maximum of 10 pages each and a maximum of 54.6 MB, 96 dpi

Please note that the presentation material and description cannot be added to or edited after the registration has been completed. Make sure you have all materials complete and correct before completing the registration.

After your application, your submission will be thoroughly reviewed by our team of experts. You will then be informed in writing whether your submission meets the required criteria and has thus been nominated for participation in the 2025 ETA -AWARDS. In case of non-admission, you will also receive a notification.

Jury committee

The European Textile & Craft Award is decided on by an independent international jury of experts made up of representatives from colleges, universities, crafts and industry, arts and culture.

Awards

The jury will select "Award" winners in each category, as well as an appropriate number of "Silver" winners. In addition, "Special Mention" awards are given for particularly noteworthy achievements.

Evaluation criteria

1. Overall concept
2. Aesthetic and functional design,
3. Quality of processing
4. Processed material or fibres
5. Sustainability

The above order does not represent an evaluation ranking for the jury. The jury is free to weight the individual criteria in the application. All applications submitted in due form and time will be presented to the jury for adjudication.

The Awards - Sections

Participation in the European Textile & Craft Award is possible in different award categories. You can register your application multiple times – i.e., in those individual categories which you deem appropriate. Below you will find the categories of the subject areas

The Award Categories

- Textile Craft**
Textile crafts in the fields of weaving, dyeing, knitting, embroidery, upholstery, textile printing, millinery, etc.
- Sustainable Fashion Craft**
Fashion Craft, Custom Tailoring
- Sustainable Fashion & Textile Industry**
Sustainable industrial processing in women's and men's fashion, as well as in the textile industry
- Textile Art**
Textile art, exhibition installations, etc.
- Textile Architecture**
Textile constructions with membranes and ropes. Architecture of buildings of all kinds (Public buildings, sports facilities, industrial and corporate buildings, residential buildings, museums, hotels, etc.)
- Textile shading systems**
Textile shading system, tent constructions, etc.
- Architecture with Natural Fibres**
Contemporary architecture with fibres, e.g. from hemp, flax, straw, bamboo, willow, bark and renewable plant fibres, bark and renewable plant fibres. The extraordinary ecological and aesthetic qualities of natural fibres as building materials of the future are manifold.
- Interior**
Home fabrics and carpets, upholstered furniture, upholstered beds and home accessories, textile printing, Indoor and outdoor.
- Costume Designer**
Independent artistic design and creation as well as the tailoring and organisational realisation of the costumes for the film.
- Film Set Decoration**
Independently design, place and drape fabrics, furniture and props for a harmonious set design for the film.

- Hospitality**
The award recognises hotels, inns and gastronomy establishments that have recognised the quality of textile furnishings in all guest areas for their competitiveness.
- Museums, Collections, & Archives**
The aim of the award is to recognise outstanding museum, collection and archive work and to highlight the quality of museum presentation and mediation work as well as the efforts to preserve "textiles" in all its areas as a cultural asset and to make it accessible to a broad public.
- Other (Textile subject areas that do not appear in the aforementioned categories, registration upon request)**
